Nursing Reward Program

Our state needs nurses like you: committed, enthusiastic, and genuinely interested in providing quality healthcare to Rhode Islanders.

Federal studies and local authorities have found that Rhode Island is facing a nursing shortage.

The Rhode Island Student Loan Authority (RISLA) aims to address this problem and encourage those of you who are considering a career in nursing to put your talents to work in Rhode Island.

For the first four years of your nursing career, we can offer you ZERO interest on your qualifying non-federal RISLA student loans if you meet the criteria listed below.

What does this mean? It means reducing your student loan payment by approximately 26% or more for four years. It means easing the financial burdens you face after graduation. In addition, it means giving you the opportunity to do what you where trained to do...provide Rhode Islanders with the top-notch medical care they deserve.

RISLA's Nursing Reward Program will be made available to qualified students. Our goal in offering this exciting new program is simple: we want to keep prospective nurses in Rhode Island, where they can make a difference in the lives of all Rhode Islanders.

When you graduate you will be eligible if you:

- Have an eligible non-federal RISLA student loan issued on or after July 1, 2011
- Are a licensed registered nurse in Rhode Island
- Work for a licensed healthcare facility in Rhode Island a minimum 20 hours per week
- Are providing direct patient care
- Have your application annually certified by your employer

There is a limit on the number of students that RISLA can accept into the Nursing Reward program. Applicants will be reviewed and qualified on a first come, first served basis.
